#### **GROUP REGISTRATION and RENEWAL PROCESS**

#### **PREAMBLE**

**Student-Organized groups**, defined as Common-interest and Recreation Clubs, Course Unions, Class Projects and Student Events, must register with the Camosun College Student Society to be endorsed, apply for funding, and receive logistical support. Existing groups must renew their status before the end of the first month of each semester to be recognized. All required forms are online, at: http://CamosunStudent.org/Clubs/Forms

### **GROUP CATEGORIES**

Common-Interest Clubs: minimum of 10 members; meet regularly; anyone can join; extra-curricular activities.

Recreation Clubs: minimum of 10 members; regular activity schedule; anyone can join; indoor/outdoor sports.

Course Unions: faculty sponsored; program based; holds at least one public seminar per semester (Fall/Winter).

Class Projects: short-term activity; not anyone can join; results in a physical product or organized event.

Student Event: extra-curricular; open to general public; complies with CCSS requirements; Camosun Students.

## **NEW GROUPS**

Newly formed groups **must** register themselves online, at: http://CamosunStudent.org/Clubs/Forms. This process is a pre-requisite to funding applications for all groups. Common-Interest or Recreation Clubs must also submit a membership registry before their club is ratified and eligible for funding. Please see the application form for full details about requirements and restrictions for registering a student group.

### **RETURNING GROUPS**

Continuing groups **must renew** their status with the CCSS **before the end of the first month of each semester** (January, May, and September) to be endorsed by, apply for funding and receive support from the CCSS. This process is much more simplified than the registration process. Any groups who do not renew their membership for two consecutive semesters will loose their group status and must re-register their group to be recognized.

#### **GROUP MEMBERSHIP LIST**

Only "Common-Interest" and "Recreation" Clubs who are registering OR renewing their group status in September must submit a list of the current group membership. All clubs require at least ten (10) current students. The membership list is required to demonstrate the membership requirements are met and to provide the club organizer with contact information for members of the club. Membership may affect funding decisions.
