a) Virtual tour consultation-Rodney Porter, Executive Director of Communications and Marketing, thanked the CCSS Board of Directors for the opportunity to share this presentation his department has been working on. He explained that a while ago his department decided to do a capstone project and after looking at the college website one of the ideas that was pitched was a virtual campus tour. Rodney introduced his colleague Lorena Parra, who was a capstone student, and has since become a term employee at the college. She spearheaded the virtual campus project. She has been working on this project for the past four months, she noted that this initiative has been student driven. The project was designed to raise awareness and promote services available to students on campus. a) Christmas food drive discussion-Christine explained that herself and Elva have been meeting and working out details for the Christmas food drive that will start later this week. Christine has an announcement going out in Cam News tomorrow, Elva will be sending out an email later today asking board members to assist with this project. The project entails dropping 10 boxes to various departments around the college and encouraging faculty and staff to donate non-perishable items and money to this CCSS food bank.
Christine explained to the new members that there are two CCSS food banks one on each campus and students that are in need can take two items a day. She noted that last week she opened registration for the CCSS holiday hampers and within an hour all 48 hampers for Interurban had been claimed. Two hours

after that the 48 hampers designated for Lansdowne had been claimed. It shows that there is a real need for the services like the food bank and that students are really struggling right now. What **Christine** is looking for is five people per campus to sign up to pick up boxes and deliver them to their respective departments and find out who the contact in that department is then send a follow-up email asking staff in the department to donate. **Christine** is going to pick up some gift cards as an incentive for staff and faculty. Once they donate, they can enter a draw to win one of the gift cards. Assistance will be needed Friday, December the 1<sup>st</sup> to assemble CCSS holiday hampers at the Lansdowne campus. **Christine** will be sending out an email related to that after this meeting. Please let her know if you can help. She will also be sending out another email, she has 3 tickets for a fundraising event being held at the Dunlop house Friday November 24<sup>th</sup> so look out for that.

b) Nexus wellness promotion agreement-**Michel** explained that this item is related to the Nexus referendum that did not pass in the fall 2023 CCSS election. The Nexus is Camosun College's student newspaper and does some very good work, they also share a collective agreement with CCSS employees. In the most recent CCSS election the Nexus newspaper held a referendum which would have given the Nexus Publishing Society a sustainable budget. The referendum didn't pass. **Michel** mentioned at the last in person Board meeting that the CCSS could give the NPS a lifeline to help them in these times of high inflation to help them cover wages and other expenses which would allow the NPS to function until it's feasible to run the referendum again. The idea is that the CCSS would enter in to a 1-year Health and Wellness promotional agreement with the NPS (Draft Agreement attached to the agenda)
