III PRESENTATIONS/RESIGNATIONS/ GUEST BUSINESS/ ANNOUNCEMENTS ETC

- a) Threshold Housing Society-Jo-Ann Roberts_Jo-Ann Roberts from the Threshold housing society came to give the board a presentation on the Housing Society and their goals and purpose. A short round table ensued. Jo-Ann explained that THS targets at risk of being homeless youth from 16-24 years old. She went on to explain THS is about transitioning youth from being at risk to being adequately housed, educated and employable. THS offers life skills workshops and helps youth get educated. She explained homelessness is a nationwide problem and it is more prevalent in Victoria here because of the cost of living and the rental vacancy rate being less than 1% along with the fact that not many Landlords want to rent to youth. There are also issues with housing homeless LGBTQ youth. THS offers both male and female housing as well as LGBTQ available along with scattered housing where THS assumes the rent. Clients must be in school, working, or taking programs to better themselves. Tenants pay 30% of rent and 30-40 clients are currently with THS. THS pays market rent to landlords. Mehtab & Zach had questions. Mehtab's regarded roommates and Zach regarding gaming grants. Carlos raised a question about addiction and was informed THS does offer post treatment housing. THS offers a 2 year program leading to education or employment. There is a two week intake process at THS and there are a lot of clients with mental health issues. THS receives money from the United Way & the Victoria Foundation and no clients over 22 years of age.

Shayli explained that all CCSS meetings are run with Robert's rules of order. They are used so everyone has an opportunity to speak in an orderly fashion. She went on to explain about motions, movers, seconders, points of personal privilege, and explained that you do not directly talk to meeting participants but to the Chair. Shayli also talked about calling the question and tabling motions as well as Points of order.
