a) \$5000.00-Donation to the CCSS Supplemental Access Fund with Financial Aid-Michel

Michel reported that there are several funds run through financial aid and that the Supplemental Access Fund was created some years ago to fill in the gaps between the government-funded program that helps students with academic upgrading the supplemental grant helps students that don't qualify for the academic upgrading grant but can't necessarily afford to pay for classes the fund was created as a \$20,000 amount and usually about \$5-\$7000 is spent per year Michel stated that we need to top up the fund because there is only about \$2000 left in it and we need the fund to be stable for the next fiscal year so the students that use it don't fall through the cracks he also mentioned that he would like to meet with the Camosun College foundation to discuss cost sharing

Michel stated that at the last Board meeting he explained to Council that there had been some bills and expenses paid by the signing officers as well as urgent decisions related to the well-being of students and their ability to participate in classes he noted that this morning a situation came up with the student registered with the Centre for Accessible Learning that is unable to be assessed for learning disability status because there is no way to do that over videoconference and would likely be denied the monies needed without the CCSS' intervention he also noted that this situation is complex and unique and is directly related to the Covid 19 situation his question was would Council like payments and decisions like that to continue to be made by the signing officers and then have the signing officers report to Council or would Council like those expenses brought to the Board for the sake of consistency the signing officers will continue to pay bills and expenses and make urgent decisions and then report back to the Board? After some conversation Board members supported the signing officers making these decisions and

a) Executive Director's report

Michel reported that the last 2 weeks have been very busy he has been averaging about 3 videoconferences a day with college administration or their Covid response team the college has been responding and responding quickly to various things the main thing he wanted to share with Council is that we won't likely be seeing the pass fail credential unlike UVIC and several other institutions that being said in this strange who knows what could happen he also reported that the college has received \$140,000 in emergency funding from the province of British Columbia for domestic students he also noted that there was \$60,000 earmarked for indigenous students the Erasing Barriers fund is the only fund that is able to support international students therefore the requests received from domestic students are being redirected to the above-mentioned \$140,000 in emergency funding so that the Erasing Barriers fund can be used to address the needs of international students Michel reported that there has

been upwards of 700 applications for that fund alone from international students the college is going ahead with the next semester online there is a one-time discount of \$1000 offered to international students to entice them to and roll in spring and summer courses
