- a) Introduction to the Canadian Alliance of Student Associations **Fillette**Let the new members of Council know what CASA is and explained that it is our national affiliate and the main focus of the organization is advocacy they advocate on behalf of students on the national level to the federal government there are 23 member locals across Canada the CCSS joined in November 2018 and our delegates attended advocacy week in Ottawa Member locals have 1 primary and one secondary delegate the structure is somewhat similar to the structure of the CCSS members of the CASA executive are elected in May at the Foundation's conference CASA meets 4 times a year once in March for an AGM then Again in May for Foundations and in July for policy strategy planning and then in November for advocacy week they are in regular contact with the CCSS via email with updates
- b) Building Fund Report **Michel**

Explained that the CCSS has a building fund one day we hope to be able to build our own space the fund is managed by the Camosun College foundation it should be noted that as a nonprofit organization the CCSS cannot make profit but is allowed to have funds where the retained earnings can go **Michel** shared his screen to show members the amount of money in the fund today he mentioned that due to Covid 19 there was some losses but most of that money has been gained back it's worth mentioning that the fund is somewhat flexible it could be used for possible renovations at the Lansdowne campus which would help us out in the short term or to build a building on the interurban campus but there is not enough money in the fund to do both of those things questions were taken from the floor

IV Financial Motions/Issues

a) \$77,869.58-British Columbia Federation of Students (BCFS fee payable September 2019-March 31, 2020)

Michel noted that usually this payment comes quarterly but since there has been a bit of a fee restructure and we were having some difficulty getting numbers from the college we had to wait until now to pay it (this is almost the full amount of fees for the year)

Michel said he's been busy with meetings he also reported that the new ombudsman has been quite busy more students are starting to utilize his services he noted that the semester that started today student numbers are down 15% from what they were last year at this time he also mentioned that the federal government has passed the Canadian emergency student benefit next he reported that the college is somewhat concerned with its budget the college received a letter from the government stating that they need to live within their existing budget for the fiscal year there'll be no injection of cash from the government to post-secondary institutions 80% of the college's budget is wages there is going to be some planning on the college's part as to how to move forward Michel said he has spoken strongly in favor of keeping the services that students need operational and that he'd let Council know more when he knows more he took questions
