Benjamin gave an outline of what the business does and why Nimbus was started he explained that the service works with several schools across Canada and working their hardest to keep the costs to students down while still providing an accessible quality virtual face to face experience due to the current COVID-19 situation there is app which offers booking options, reviews, as well as a whiteboard feature most tutors utilized are from the same institution as the consumer and lots of the tutors are volunteer the students tutoring sessions are available in different languages there are also options to share sessions or make group sessions which should be rolling out in September or October as for cost the cost is based on FTE and ranges from \$1.50-to a little over \$2.00 the way that it works is the CCSS would pay for the rights to use the services then the students would in turn pay the tutors this program has only been working at 4 year program schools no community colleges thus far they took questions from the floor
