a) Executive Director's report

Michel reported that himself, Amanda, and Fillette attended a CASA policy conference today he reported that doing these conference via Zoom has its challenges but there is still lots of good information presented and they did have an interesting musical interlude for one of the breaks today the conference goes from Monday the 27th until Thursday the 30th with Tuesday and Wednesday mainly being committee meetings that Thursday will be a heavy day because everyone will be on the same video feed he also reported that the CCS is going to cease selling the summer U-Pass the last day the passes will be for sale is August 4 after that date we will be getting prepared to start selling the Fall non-enrolment U-Pass as well as helping to distribute the regular U passes to students which might be a bit of an organizational challenge for us he has also been working hard with student affairs to organize some sort of CamFest/student engagement activity likely some virtual activities as well as distribution of our swag bags but it will be on a very limited scale and there will be no food the relationship with Island Sexual Health may look slightly different this year as well due to Covid we subsidize the cost of the clinic on the 3rd floor of the Richmond house the college and the CCSS were looking at expanding that footprint to the Interurban campus as well this year but after conversations with the director of student affairs and the director of Island sexual health there was some question around is it even worth having clinics on campus if there are no students or a limited number of students on campus perhaps it may be better to stream students towards the Quadra Street location of the Island Sexual Health Clinic for this year Michel has been in contact with the registrar and they have been discussing fees for e-Prentice students and he wanted to make sure that this issue was dealt with in a timely manner but there is a big difference between the length of time in the online program (6 months) as opposed to the on-campus program (6 weeks) and that student Society fees are charged on a monthly basis so those students doing the online course will be getting charged substantially more student fees that the on campus students and that is not really fair

Whereas there are a small number of online and largely out of town students enrolled in the 5-6 month Chef Training E-Prentice program and if they took the course on campus it would take 6 weeks; and

Whereas the tuition for the two programs are the same but the student fees are considerably higher; and

Whereas official discussions between the CCSS and Camosun have started to resolve various outstanding fee concerns; therefore

Be it Resolved That the CCSS Board of Directors authorise the college to charge students enrolled in the E-prentice program student society fees equivalent to those paid by on campus students for the same program until August 31st 2021; and

Be it Further Resolved That Camosun College be authorised to automatically opt-out the E-Prentice students from the U-Pass if the students live and study outside the Capital Regional District boundaries. **CARRIED**
