a) Executive Director's report-**Michel** reported that the college will likely end the fiscal year with a \$7 million deficit which will create a bit of a challenge for the college moving forward because they will have to carry forward this debt and have a plan in place to pay it off in a timely manner (within the next two years) he also mentioned that normally there is legislation in place that prevents colleges from running deficits **Michel** expressed some concern as to how the college would be able to pay back the debt adding that they may be relying on an influx of international students coming in

September 2021 but related to that international numbers are down significantly compared to Fall because of increasingly stringent travel restrictions while domestic numbers are only down about 2% **Michel** did mention even though no one could have been visions that we would be in the midst of a pandemic we do have the BC Liberals to blame for our current situation surrounding international student fees because the party deregulated tuition fees when they were in power **Michel** happily reported that the bookstores are open and functioning much better than they did last semester the safe start process is also working much better than it was in the Fall semester between 28 and 30% of all students that are registered have some sort of on-campus component to their studies this semester the college is planning on having a larger on-campus experience for students in the Fall of 2021 it is also Camosun's 50<sup>th</sup> birthday this year and the college is hoping to do an event related to that **Michel** also touched on the provinces newly unveiled vaccine rollout schedule the student Society offices are open four days a week although they will be closed on reading break **Michel** took questions from the floor

b) BCFS AGM reports-Quinn C reported that him and other CCSS delegates attended the BCFS AGM via zoom over the past weekend (three days) there was a lot of good conversation about where the federations campaigns are at the BCFS has joined a new federal student advocacy group long time BCFS staffer
