Just before he went on vacation, he attended a health and dental conference in Ontario with **Christine**. At the conference they learned about new products the CCSS' insurance broker is offering one product of interest was doctor's offering an e-health service in partnership with Telus (the doctors would be able to prescribe medications and other things and apparently you get served within 2 hours but there is a fee attached to using the app. They are going to do some research on the app/program and perhaps bring it to students through referendum. It may be very useful to members because finding a doctor in this town is not easy. He also mentioned that the broker has some new IT professionals onboard and they will be revamping the website and improving the software staff use to process opt outs, add ons and benefit cards.
