There was an extensive discussion that took place where Board members and staff alike raised concerns about how this policy would benefit members and what kind of concessions would be allowed and who decides what is allowed whether it be cultural, illness, or other. This was a particularly concerning for members because it seems the instructors would have all the power to grant or deny concessions which is no different than the current "policy"
