Some of the campaigns the BCFS has been working on are lifting interest on student loans and the access BC campaign for free contraceptives as well as the Fairness for International Students campaign. Some CASA Highlights were getting the cap lifted on working hours for International Students. Canada student grants have been increased by 40% Jessie had the opportunity to travel a few times in her role and has enjoyed her time with the CCSS. May 1<sup>st</sup> she is going to work for the BCFS on the

mainland.
