b) Special Events—Regina/Daniella / Hector updated the board on the Day of the Dead event. VI Member Reports

a) Pride Report – **Acacia** brought to the board a student who is facing homophobia from a peer, and has been forced to downsize their quantity of classes to avoid subsequent harassment. They have spoken with teachers, asked the other student to gender them correctly, and then made an official complaint to the OSS. There is currently no solution since they need these courses to continue with their studies. The OSS has not offered a concrete solution.

Maddy suggested a no-contact order administered by the OSS. Acacia states that that is the process that is undergoing, however this has been ongoing for two terms now. Madison suggested that Acacia sit in on a meeting with the student.

Michel suggested the student speak with the Ombudsperson to get a good idea of how the OSS works, since informal reporting does not activate a response. He also stated that these circumstances violate the current code of student conduct.

Sean suggested speaking with the teachers to understand where the training failed so that support can be offered in the future.

VI Other Reports

a) Executive Directors Report – **Michel** attended the Prov. Exec. meeting last weekend. He states that it was a lot more doom and gloom than any other meeting he has been to in the last few years. He attended a round table where there were guiding questions regarding program cuts, though Camosun has not yet seen these program cuts. We have lost some entry points to the College, but the programs still exist. Loss of services was an area where Camosun could participate with the loss of international advising and the stall on free textbooks. The biggest threat is the subtle shift towards modified tuition protections, removing the 2% cap on domestic tuition changes. Camosun even highlights this as one of the reasons Camosun currently has a deficit. **Michel** states that **Terence** will have more to say next meeting.

The AGM will be happening at the end of January or the beginning of February in Richmond. Due to the World Cup coming to Vancouver, the meetings next year will be moving to Prince George due to hotel costs.

VII Question Period

Sean asked for a Nexus update. **Michel** responded that nothing has changed, as the Nexus has asked for a pause as they apply for a publishing grant that could cause a change to their needs. **Sean** asked if there were any other efforts in place to make the Nexus more engaging or of interest to students. **Michel** states that there is a desire on their part, including an online mailer; however, these efforts would come with their own set of financial or manpower needs.
